THIS AGREEMENT for snow removal and related services made this 8th day of January 2024 by and between T.D. Snow Removal (T.D.) and The Waterford Condominiums (Owner/Agent).

In consideration of the mutual promises and covenants set forth herein, the parties agree as follows.

- The term of this contract for snow removal services shall commence on the date hereof and shall terminate on April 1, 2024.
- During the term of this Agreement T.D. shall undertake snow removal and related services at the owners
 property located at 3333 University Blvd West Kensington MD 20895. Snow removal services shall include
 snow plowing, sanding and/or salt treatment of roads and sidewalks, generally used by the public at the
 property.
- 3. Snow removal services shall commence upon the accumulation of two inches (2") of snow at the property location unless other agreed between the parties. Snow removal shall be conducted in a manner so as, first, to keep the main streets and roads open for vehicular passage. Thereafter, and at the conclusion of the snow event, T.D. shall then undertake the clearing of parking spaces, sidewalks and other areas.
- Sidewalks will be cleared and then treated By the owner.

Owner shall make payment in full within (30) days of the date of the invoice. All invoices unpaid after (30) days shall incur a late fee of 1.5% per month of the overdue amount. In the event that T.D. is required to undertake collection procedures on invoices unpaid after thirty (30) days, Owner also agrees to pay all cost of collection, including reasonable attorneys' fees and court cost, incurred by T.D. in collection of overdue accounts.
